There was a motion via email for the Vancouver and District Area Council to pay \$100 for Tim Hortons coffee, tea, and snacks to support the HandyDart workers on the strike line at Pacific Central Station, as a political action expense.

### 7. Acceptance of the Previous Minutes of July 17, 2024 Moved by Denzil, Seconded by Priscilla. Carried.

### 8. Business Arising

**Report from President re: PSAC National Convention.** Jennifer felt very privileged to represent VDAC. Our resolutions were dealt with as follows:

Our resolution regarding 'Search the Landfill' was combined with other resolutions and was carried.

Our resolution regarding affordable childcare was combined with other resolutions and was carried.

Our resolution regarding Solidarity with Women Life Freedom and Iranian Workers did not make the floor, however dealt with and carried on June 25, 2024, as there was no cost.

Our resolution regarding tax credits for transit users did not make floor.

Our three resolutions regarding travel policy these were not included and were removed on the basis they could be dealt with internally because the National Board of Directors has the power too make the changes. This matter has been given to Jamey who will get back to us.

Our resolution regarding Remote Work language did not make the floor.

Our resolution regarding Affordable housing and Rent Control was voted down due to high costings (2.5 million dollars).

The budget was passed in record time. There will be a dues increase of 4 cents per member per month with new fiscal year. There will be an increase of \$1 per member per month to support higher strike pay

in the new cycle, 2025. Jennifer was proud to address the convention of the issue of whether increases to dues for one time costs ever come off the dues, and state that she had monitored this and seen a decrease when this happened.

Report from events since last meeting We estimated much better about the food for the barbecue. We had 50 or 60 members. The Mainland Human Rights Committee, Women's Committee, and the Haida Gwai Young Workers Committee were also involved and did good work. We have lots of left-over soda, and burgers. We had good information for the public, particularly about lighthouses (<a href="https://unioncte.ca/ccg-dont-destaff-light-stations/">https://unioncte.ca/ccg-dont-destaff-light-stations/</a>), as well as information about Phoenix and other issues. Many members stopped by, particularly at Labour Day.

### 9. Financial Report

The bank balance is \$2769.

From July 17, 2024, onwards we had some payments such as reimbursements for park rental, and dues, and we had payments out, mostly to various people for reimbursements for the barbecue. The Haida Gwai Young Workers gave \$100 towards the barbecue. We donated \$100 for snacks for a political actions to support the Handidart strike. We paid \$500 to the Metro Vancouver Alliance. We spent quite a bit for member engagement, and not much for political action. We have \$300 left for donations.

Acceptance of the report was moved by Damir, Seconded by Lauri. Carried.

### 10. Standing Updates

A. Phoenix: - There was a report from Ann-Marie. HR and Pay which is replacing or adjusting the current Phoenix Pay centre system is moving along. Quarterly reports are being produced and listed online - https://www.canada.ca/en/public-services-procurement/services/pay-pension/pay-administration/integrated-strategy-human-resources-pay.html. There is a Facebook group as well

- https://www.facebook.com/GCEmployeePayBenefits. They are using AI to handle the backlog. They named the AI: Buffy the Backlog Slayer it's a play on Buffy the Vampire Slayer.
- **B. Metro Vancouver Alliance:** They have been moving towards action. David Barrows, Regional Director Industrial Areas Foundation (IAF) NW/Pacific who comes from Australia. IAF is the parent organization for MVA. They want to work on housing municipal elections in Vancouver and Surrey. Do we have the resources to launch the campaign, particularly in Surrey? There are Metro Vancouver Alliance training sessions on Individual Donor Campaign Training, on October 22, 2024, at 6:30 via Zoom, led by IAF leader from Calgary. A course, Foundations of Community Organising, is training about what the Metro Vancouver Alliance and IAF are and how they operate. This will be November 3 & 10, from 12:00 - 5:00. There have been efforts to be more inclusive to include Jewish and Christian people on a day which is not the Sabbath, and which would allow people to attend church on Sunday before the training. We need longer lead times for training. There will be more courses of Foundations of Community Organising courses, but we don't know when these will be held. These arena person. Jennifer is sitting board member of the Metro Vancouver Alliance. There is an effort to make sure members are current with their dues and and effort to separate teams so people can focus on their duties. Will we support their housing campaign? The Metro Vancouver Alliance wants to build more affordable, coop housing in the city of Vancouver. How it proposes to do this is to encourage the City of Vancouver to build new co-op development on empty city-owned lot, using funding from BC Builds program; to maximise the amount of co-op units in new build; and to use new builds as temporary housing to house co-op residents while their co-ops are being redeveloped, increasing the overall stock of co-op housing in the city.

There was a motion that VDAC support the MVA co-op housing campaign. Moved by Lauri, Seconded by Priscilla. Carried.

ECCC term rollover has been stopped. Managers are telling staff that there is a hiring freeze or budget cuts to justify not extending terms or cancelling sunset program employment early. Please see attached email for specific details.

ECCC Enforcement has created a group of employees to aid each other. The head of the group got a 2024 departmental inspiration award. I sent the group's website http://cfeoa.com to the UHEW Enforcement advisor as I believe this type of group should have some union involvement.

- B. Return to Office: Do we as an area council want to plan anything to support the campaign opposing the return to office? There is a joint union campaign at <a href="https://www.acep-cape.ca/en/telework-local-organizing-committees">https://www.acep-cape.ca/en/telework-local-organizing-committees</a>. Various workplace situations are different. We could call workers... because they can put a sign behind them if the backgrounds are not allowed. There may be other actions about which we could call them? Many offices are bing unreasonable about maintaining in-office days even if circumstances would suggest otherwise. Do we want to set up a call-hub to call members and tell them... something? We will put this out to other councils. There was a brief discussion about the recommendation to file grievances.
- C. Motion to support New West Pride There was a motion that Vancouver District Area Council contribute 1/3 of the cost of our PSAC BC booth at New Westminster Pride (\$175) from VDAC's Member Engagement budget line item. New Westminster Pride occurred on August 17th, 2024. The full \$525 vendor fee was paid by the REVPs office earlier this year so this payment would be paid as a partial reimbursement and was sent via Interac money transfer to HarrinT@psac-afpc.com.
