# **Land Acknowledgement:**

As we are gathered for our meeting tonight, we remember that we are settlers on the uncle traditional territories of the Coast Salish people, including the Musqueam, Tsleil-Waututh, and Squamish peoples, who have been the stewards of these lands since time immemorial. # **Business Arising:**

1. Election Activities Report Back

We did a texting session over two nights texting all members in Peter Julian's riding. There were technical errors the first night, however it was corrected for the second night. The platform we used could be a useful tool to reach out to members. There was less response than we had hoped for. There was a lot of fear motivating the election. This can easily be done by a small group of people.

2. Annual summer barbecue

There were 60 to 70 people. We provided burgers hot dogs. There were some guests from the passport group who had just been laid off. It was good to get perspective on what the cuts are doing. Jenn was able to revisit this experience with her MP. He seemed receptive.

3. Report back from Labour Day

We participated in the VDLC and NWDLC Labour Day event at Edmonds Park. We will definitely need to plan for more swag for such a large event in future. We also

need more material for talking points. The event was well-attended by members of the community and there was participation by many groups.

# **Financial Report:**

Currently the balance is \$4309.80. There was a deposit \$2018.43, a yearly deposit from the REVP office. There was food for the barbecue. There was some interest earned. We had some funding for New Westminster Pride from the REVP office, but we had been given some funds for this. There was food for the last VDAC meeting. We need to reimburse Shane for ice for Labour Day and Jenn is owed ice money for the barbecue. We have spent nearly all of our member engagement budget of \$1500. We need political action items. We had talked about the zine-making workshop.

# **Standing Updates:**

#### **Return to Office**

Martha says they are required to work three days in the office but there is talk in the news and among members that they may make people go back five days a week. We (VDAC) cannot speak to that definitively, but it is best to speak to someone in her component. Some may be following Doug Ford who is mandating this for Ontario workers. Workplaces and components are all different. Martha says there are not enough desks for everyone to come back five days a week. Damir says it is a PSAC-wide problem, and the requirement is poorly thought-out and disruptive. He states that after people were settled with difficulty in an existing area that SFU took back several floors of the building, but there was construction, and some floors need to be built to accommodate workers. Damir was concerned the new office would be an open concept office where people were dealing with confidential information. Jenn said that this was a particular conundrum with government cutbacks and that there is a movement sell redundant buildings to combat cutbacks. Lauren said that moving back and forth was disruptive.

#### **Metro Vancouver Alliance**

Jen attended the strategy team meeting August 28 regarding the delegates assembly. Late in the day they found they could not use the planned location. They had it at the Unitarian Church at Oak and 49<sup>th</sup>. The launch of the Climate Action Team took place. You can contact Jenn if you want to meet with them. They hold their meeting daytime during the week, however. There was a welcome and land acknowledgments. There were two new member organizations. The housing update regarding co-ops found that work was still challenging with no willingness from the city to build new buildings on the land where co-ops have existed. We are probably looking at a new coop hoping campaign. It will start as a letter writing campaign to Christine Boyle, housing minister. Important upcoming dates are a

delegate assembly in May 2026, and a municipal election assembly on September 23, 2026.

#### **Phoenix**

Scott said that Phoenix is contacting people in a new round of overpayments more than six years old for 2016 and 2018. Damir said he had a few members reach out, but it was 2018 and 2019 overpayments together, so some were prior to six years. He has had members who said they did not receive letters and some who were out of the country and did not get letters, where Phoenix just started clawing back overpayments without having contacted members. It is disturbing that Phoenix is taking funds from pay if there is no acknowledgement of knowledge of overpayments from the member. Jenn will try to find out what PSAC is doing about this default position.

#### **Bargaining Update**

As the government moves ahead with plans to cut tens of thousands of public services, the Treasury Board tabled a proposal that would strip workers of the power to negotiate improvements to the workforce adjustment process. During negotiations with the PA, EB, TC, and SV groups from September 10 to 18, 2025, they proposed removing the WFA appendix from the collective agreements of over 155,000 members. If that happened members would only be covered by the National Joint Council (NJC) WFA directive. Unlike collective bargaining, the NJC process does not let members negotiate improvements directly or to vote on job security language.

### 1. Community Activities

The VLDC is holding a rally from 2pm to 6pm on October 1, 2025, at UBC at the plaza outside The Nest. The rally will call for all levels of government to fund the SkyTrain extension to UBC. There is a petition to support a resolution to declare housing a human right in BC on the VLDC website. The petition is to be sent to the Union of BC Municipalities. The Canadian Labour Congress is holding a webinar on October 2, 2025, at 12:00 ET called "Protecting Labour and Human Rights Ahead of the FIFA World Cup 2026". Speakers will be Ambet E. Yuson, BWI (building and Wood Workers International Union; Todd Brogan ITUC (International Trade Union Confederation); Aline Nizigama, YWCA Canada; and Jennifer Li, Dignity 2026. See VLDC for more information. CoDev is going to be presenting an event entitled "From Honduras to Canada: Workers' Rights and Global Solidarity" at the Russian Hall on October 2, 2025, at 7:00pm. There will be another event entitled "Resisting the Blockade: Building Solidarity with the Workers of Cuba". This is a free even October 20, at the Aboriginal Friendship Centre on Hastings St. at 6:30pm.

#### 2. Pickle Ball Tournament

We were looking at organizing this as a community building event. We looked at some indoor locations, one with nine courts and spaces to have food and catering. There are many things going on, however, and we think it would be better to promote it well ahead of time and to hold this in 2026. The space particularly wants the number of people, so we need people to sign up and be committed to attending.
